Bulgarr Ngaru Medical Aboriginal Corporation (BNMAC) is a not-for-profit Aboriginal Community Controlled Health Organisation, providing primary health care services to Aboriginal people throughout the Clarence and Richmond Valleys through its' network of clinics in Grafton, Casino, Maclean and Tweed Heads South.

The role:

This position aims to strengthen social and emotional wellbeing wherever possible by providing positive interventions for Aboriginal youth so that they can be strong, healthy and resilient individuals, which in turn may enhance pathways to education and employment and reduce substance abuse, violence and contact with the criminal justice system.

The services delivered will be to Aboriginal youth between the ages of 12 – 24 years.

The Aboriginal Youth Service must improve community wellbeing and resilience by providing the following services:

- I) Activities targeting individuals
- II) Activities targeting groups
- III) Activities targeting the community

The position will work in conjunction with a range of stakeholders, including but not limited to BNMAC GP's, Headspace, Camellia Cottage, CRANES, Local Aboriginal Land Councils, Gurehlgam Corporation, Intensive Based Family Services and primary and secondary schools. Also link with existing networks, including Clarence Youth Action, Community Drug Action Team, Clarence Valley Interagency and the Our Healthy Clarence Steering Committee.

Selection Criteria:

- Minimum Certificate IV qualification in Aboriginal Health
- Aboriginality is a genuine occupational requirement of this position.
- Current NSW Working with Children Check
- Willingness to assist and support team members as required
- Current Class C driver's License
- Ability to hold all relevant security clearances including National Police Check
- Computer proficiency and the ability to use basic computer programs, information management systems, including the capacity to write reports and collect statistical data.
- Sound knowledge of community health, public health and Aboriginal Health
- Ability to develop and foster collaborative working arrangements with relevant services and organisation.
